First, your application will now pass to NIH's Center for Scientific Review where it will be assigned a unique identification number that looks like this: 1 R43 AI183723 02 A1 S1.

The **February 2024 cohort** of BBCetc's Women Catalyst Advantage Network (Women-CAN) is forming now. - The company intends to submit to SBIR/STTR or already has an SBIR/STTR award.

The NASA submission period opened on January 9, 2024. NASA seeks technology ideas for space and on Earth to address NASA's wide-ranging goals. Proposals are due not later than 5:00 pm ET on March 11, 2024.

SBIR/STTR: Foreign Ownership Requirements (Virtual)

January 24, 11:00 - 12:00 pm ET

If you are planning to submit an SBIR or STTR proposal, the 2022 SBIR/STTR Reauthorization now requires disclosure of foreign influence.

Each agency handles this disclosure requirement somewhat differently, and you must know the rules to stay compliant (some agencies won't review proposals lacking the required forms). Our expert will review the required, Agency-specific forms, what level of foreign involvement must be disclosed and how to submit the required disclosures. A Q&A period is included.

NIH SBIR/STTR: Intensive Proposal Preparation (Virtual)

January 30 - February 1, 11:00 am - 12:30 pm ET daily

If you are planning to submit an SBIR or STTR proposal to the National Institutes of Health (NIH) by the April 5 submission deadline, now is the time to begin the process. In this workshop, a BBCetc expert will provide important information about SBIR/STTR funding. In addition to up-to-date information on the SBIR/STTR programs, you will gain helpful information about necessary registrations, how to approach each section of the proposal, strategies for targeting your proposal to meet the reviewers' expectations, avoiding common pitfalls, and more.
